Ord. #93 Sect. 5.a: Scope and Intent. The provisions of this section shall apply to all real estate which is connected to the City's sanitary sewer, sump pumps, and water service lines, located within the City. It is the intent of this ordinance to identify and eliminate inflow and infiltration resulting from cracked and leaking pipes, foundation drain connections, roof drain connects, and sump pump connections. These provisions will also be used to determine proper water connections including water meter and if any cross connections or back siphoning connections exist.
